Re: Bioengineering Disclosure

Regarding your inquiry on the USDA AMS National Bioengineered Food Disclosure Standard for the products supplied by Ardent Mills, LLC, the NBFDS final rule requires all food products that are or that contain ingredients from bioengineered (BE) crops to disclose this information on the label.

Currently, the following foods are on the USDA's List of Bioengineered Foods:

Note: Grain disclosure exemption – A food that contains a bioengineered substance; however, the BE substance is not intentionally added and is a) inadvertent or technically unavoidable and b) not more than five percent (5%) for each ingredient. (7 CFR 66.5 (c))

If applicable, products certified organic pursuant to the USDA National Organic Program are exempt from BE disclosure. (7 CFR 66.5 (e))
